ESTABLISH TOWNSHIP TREASURER WAGE

At a regular meeting of the Township Board of Lyon, Roscommon County, Michigan, held at the
Township Hall on the 20th day of February 2019 at 7:00 p.m.

PRESENT: Edward Nellist, Terry Cleeves, Craig Williams, Eric Carlson

ABSENT: Dolores Munoz

The following resolution was offered by Edward Nellist and supported by Eric Carlson.

WHEREAS, according to MCL 41.95(3), in a township that does not hold an annual meeting, the salary for officers composing the township board shall be determined by the township board; and

WHEREAS, the township board deems that an adjustment in the salary of the office of Clerk is warranted.

WHEREAS, the Lyon Township Board is authorizing the Clerk's office to pay the Treasurer on the first business day of each month the sum of \$ 2058.33 for a total yearly salary of \$24699.96 starting on the 1st day of April 2019 and until changed.

WHEREAS, the Lyon Township Board is authorizing the Clerk's office to pay the Treasurer an additional lump sum salary for collecting school taxes for the year to be set at \$4000.00, paid the following month the money is collected from the school and deposited into the Township funds. If the Treasurer opts not to collect the school tax for the year, this amount will not be paid out.

NOW THEREFORE, BE IT RESOLVED THAT:

1. The Lyon Township Board has approved, that as of 04/01/2019, the salary of the office of Treasurer shall be as follows: Treasurer: \$2091.67 monthly salary

2. The Lyon Township Board authorizes the Clerk's office to pay the Treasurer on the first Business day of every month in the amount of \$2058.33 for a total year salary of \$24,699.96.
3. The Lyon Township Board has approved, that an additional lump sum salary amount of \$4000.00 for collecting school taxes for the fiscal year. This salary will be paid the following month the money is collected from the school and deposited into the Township funds. If the Treasurer opts not to collect the school tax for the fiscal year, this amount will not be paid out.
